



**AWRIS Warranties in respect of Indian Ocean / Arabian Sea  
Gulf of Aden / Southern Red Sea transits within the waters enclosed by:**

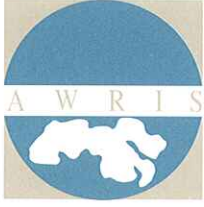
- On the northwest. By the Red Sea south of latitude 15°N
  - On the West of the Gulf of Oman by Longitude 58°E
  - On the east. Longitude 65°E
  - And on the south. Latitude 12°S
- a-d hereinafter referred to as the “Listed Areas” (excepting coastal waters of adjoining territories up to 12 nautical miles offshore unless otherwise provided).

**Warranted:**

- The assured have considered and, as appropriate, adopted the Best Management Practices to Deter Piracy off the Coast of Somalia and in the Arabian Sea Area (“BMP Version 4 - August 2011” .....hereinafter “BMP 4”) and have instructed the vessel’s master and crew to act in accordance with BMP4 prior to transit and if attacked.

Without prejudice to the generality of the foregoing, it is warranted that the following BMP4 recommendations are complied with:

- Risk Assessment (3.1)
  - Vessel/craft to proceed at Full Sea Speed (3.4)
  - Company Planning (6.1 to 6.9 inclusive)
  - Master’s Planning (7.1 to 7.11 inclusive)
  - Enhanced Bridge Protection (8.3)
  - Control of Access to Accommodation and Machinery Spaces (8.4)
  - Fitting of High Quality Concertina Razor Wire (8.5)
  - Citadels (8.13)"
- Vessel/craft not to enter waters between Socotra and Somalia Mainland
  - Vessel/craft not to approach nearer than 100 miles of Socotra Archipelago
  - Vessel/craft to stay at least 40 nautical miles to the north of Somalia between 45° East and Ras Asir (11° 50' N, 51° 16.9' E.)
  - When transiting, vessel/craft shall not call at any port or place or delay their passage to engage in the transfer of cargo, stores, personnel or the like
